SUBJECT: Fiscal Year 2018 Notices of Funding Opportunity

Today, the Federal Emergency Management Agency (FEMA), a component of the Department of Homeland Security, announced the availability of the Fiscal Year (FY) 2018 Notices of Funding Opportunity. This Information Bulletin (IB) provides details on the available FY 2018 preparedness grant programs. The Notices of Funding Opportunity released today represent \$1,687,100,000 in available FY 2018 Federal assistance and are available online at <http://www.fema.gov/grants> and at <http://www.grants.gov>.

Eligible applicants must apply for funding through the Grants.gov portal, accessible on the internet at <http://www.grants.gov>. When applicants apply through <http://www.grants.gov>, applicants must submit the Standard Form 424 in the initial Grants.gov application. The FEMA Non-Disaster (ND) Grants system will retrieve the Standard Form 424 directly from the Grants.gov system and will automatically populate the relevant data fields in the ND Grants application. To allow sufficient time for FEMA to conduct an initial eligibility review of the application prior to the final submission deadline, **applicants are strongly encouraged to submit their initial application in Grants.gov at least seven days before the June 20, 2018 application deadline.** Upon the completion of the initial review, FEMA will determine whether an application is eligible to proceed further and will notify the applicant to complete their submission by fulfilling additional application requirements (e.g., Budget, Investment Justification, Work Plan, etc.) required by the relevant grant program. Completed final applications in ND Grants for all grant programs must be submitted no later than **5:00 p.m. EDT, June 20, 2018.**

The application must be complete and only final submissions made through the ND Grants system located at <https://portal.fema.gov> will be accepted. If you, the applicant, need assistance registering for the ND Grants system, please contact ND Grants Help Desk at 1-800-865-4076. Applicants are encouraged to begin their ND Grants registration at the time of solicitation to ensure they have adequate time to start and complete their application submission.

FY 2018 Homeland Security Grant Program (HSGP)

The HSGP includes a suite of risk-based grants to assist State, local, and tribal efforts in preventing, preparing for, protecting against, and responding to acts of terrorism. The grants included under HSGP include:

State Homeland Security Program (SHSP).* In FY 2018, the SHSP provides \$402,000,000 to assist state, local, territorial, and tribal governments in preventing, preparing for, protecting against, and responding to acts of terrorism.

Urban Area Security Initiative (UASI).* In FY 2018, the UASI program provides \$580,000,000 to assist high-risk Urban Areas in preventing, preparing for, protecting against, and responding to acts of terrorism.

Operation Stonegarden (OPSG). In FY 2018, OPSG provides \$85,000,000 to support enhanced cooperation and coordination among local, tribal, territorial, state, and Federal law enforcement agencies in a joint mission to secure the United States' borders along routes of ingress from

international borders, to include travel corridors in states bordering Mexico and Canada, as well as states and territories with international water borders.

FY 2018 Tribal Homeland Security Grant Program (THSGP)

In FY 2018, the THSGP provides \$10,000,000 to directly eligible tribes to support the building, sustainment, and delivery of core capabilities to enable tribes to strengthen their capacity to prevent, protect against, mitigate, respond to, and recover from potential terrorist attacks.

FY 2018 Nonprofit Security Grant Program (NSGP)*

In FY 2018, the NSGP provides \$50,000,000 in funding support for hardening and other physical security enhancements to nonprofit organizations that are at high risk of terrorist attack and located within the UASI-eligible urban areas. In FY 2018, additional, separate funding in the amount of \$10,000,000 has also been appropriated for nonprofit organizations located outside of FY 2018 UASI- designated Urban Areas. The intent of the FY 2018 NSGP is to competitively award grant funding to assist nonprofit organizations in obtaining the resources required to support and integrate the preparedness activities of nonprofit organizations that are at high risk of a terrorist attack with broader state and local preparedness efforts. The program seeks to integrate nonprofit preparedness activities with broader state and local preparedness efforts. It is also designed to promote coordination and collaboration in emergency preparedness activities among public and private community representatives, as well as state and local government agencies. Under the Nonprofit Security Grant Program - State (NSGP-S), eligible states will receive an allocation for nonprofit organizations located outside of FY 2018 Urban Area Security Initiative (UASI) designated Urban Areas. As in previous fiscal years, the Nonprofit Security Grant Program - Urban Area (NSGP-UA) will be a competitive grant program.

FY 2018 Intercity Bus Security Grant Program (IBSGP)

In FY 2018, the IBSGP provides \$2,000,000 to owners and operators of intercity bus systems providing services to UASI-eligible Urban Areas, to protect critical surface transportation infrastructure and the traveling public from acts of terrorism and to increase the resilience of transit infrastructure.

FY 2018 Intercity Passenger Rail – Amtrak (IPR) Program

In FY 2018, the IPR Program provides \$10,000,000 to the National Passenger Railroad Corporation (Amtrak) to protect critical surface transportation infrastructure and the traveling public from acts of terrorism and to increase the resilience of the Amtrak rail system.

FY 2018 Port Security Grant Program (PSGP)

In FY 2018, the PSGP provides \$100,000,000 to provide funds to port authorities, facility operators, and state, territorial, and local agencies required to provide security services to implement Area Maritime Transportation Security Plans and facility security plans.

FY 2018 Transit Security Grant Program (TSGP)

In FY 2018, the TSGP provides \$88,000,000 to support transportation infrastructure security activities. The TSGP provides funds to eligible publicly owned operators of public transportation (which include intra-city bus, commuter bus, ferries, and all forms of passenger rail) to protect critical surface transportation infrastructure and the traveling public from acts of terrorism and to increase the resilience of transit infrastructure.

FY 2018 Emergency Management Performance Grant (EMPG)*

In FY 2018, the EMPG Program provides \$350,100,000 to assist state, local, territorial, and tribal governments for the purpose of providing a system of emergency preparedness for the protection of life and property in the United States from all hazards and to vest responsibility for emergency preparedness jointly in the Federal Government and the states and their political subdivisions. This total funding amount includes \$100,000 from the Disaster Relief Fund that FEMA must make available to the Federated States of Micronesia and the Republic of the Marshall Islands.
