Preliminary Damage Assessment Report

Oregon – Severe Winter Storm, Straight-line Winds, Flooding, Landslides, and Mudslides Denial

Denied on April 4, 2023

On February 27, 2023, Governor Tina Kotek requested a major disaster declaration due to a severe winter storm, straight-line winds, flooding, landslides, and mudslides during the period of December 26-31, 2022. The Governor requested a declaration for Public Assistance for 12 counties and Hazard Mitigation statewide. During the period of February 13-20, 2023, joint federal, state, and local government Preliminary Damage Assessments (PDAs) were conducted in the requested areas and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the state and the affected local governments, and that Federal assistance is necessary.¹

On April 4, 2023, the Governor's request for a major disaster declaration was denied based on the determination that the impact from this event was not of such severity and magnitude as to be beyond the capabilities of the state and affected local governments.²

¹ The Preliminary Damage Assessment (PDA) process is a mechanism used to determine the impact and magnitude of damage and resulting needs of individuals, businesses, public sector, and community as a whole. Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

When a Governor's request for major disaster assistance under the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).

³ Degree of damage to impacted residences:

Major Damage – substantial failure to structural elements of residence (e.g., walls, floors, foundation), or damage that will take more than 30 days to repair;

Minor Damage – home is damaged and uninhabitable, but may be made habitable in short period of time with repairs; and

o Affected – some damage to the structure and contents, but still habitable.

⁴ By law, Federal disaster assistance cannot duplicate insurance coverage. 42 U.S.C. § 5155 and 44 C.F.R. § 206.48(b)(5).
