### Preliminary Damage Assessment Report

## **Tennessee – Severe Storms and Tornadoes FEMA-4751-DR**

### Declared December 13, 2023

On December 12, 2023, Governor Bill Lee requested an expedited major disaster declaration due to severe storms and tornadoes on December 9, 2023. The Governor requested a declaration for Individual Assistance and emergency protective measures (Category B), including direct federal assistance, under the Public Assistance program for four counties and Hazard Mitigation statewide. This event was of the severity and magnitude that the need for supplemental Federal assistance was determined to be necessary prior to the completion of joint Federal, State, Tribal, and local government Preliminary Damage Assessments (PDAs). Per 44 C.F.R.§ 206.33(d) and § 206.36(d), the requirement for a joint PDA may be waived for those incidents of such unusual severity and magnitude that formal field damage assessments are not required to establish the need for supplemental Federal assistance under the Stafford Act.<sup>1</sup>

On December 13, 2023, President Biden declared that a major disaster exists in the State of Tennessee. This declaration made Individual Assistance requested by the Governor available to affected individuals and households in Davidson, Dickson, Montgomery, and Sumner Counties. This declaration also made assistance for emergency protective measures (Category B), limited to direct Federal assistance, under the Public Assistance program for Davidson, Dickson, Montgomery, and Sumner Counties. Finally, this declaration made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures statewide.<sup>2</sup>

Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).

o Major Damage – substantial failure to structural elements of residence (e.g., walls, floors, foundation), or damage that will take more than 30 days to repair;

o Affected – some damage to the structure and contents, but still habitable.
