ANNUAL GALVESTON JOB FAIR EXPECTING RECORD TURNOUT

Given the double impact of Hurricane Ike and the current economy, organizers of the Fourth Annual **Oceans of Opportunity Job Fair** are expecting a record turnout of both employers and job applicants.

The event is scheduled for Tuesday, Feb. 17 from 9 a.m. to 2 p.m. at the Galveston Island Convention Center, 5600 Seawall Blvd., Galveston, TX 77551.

Last year about 2,000 people showed up to meet with 140 employers. This year, 200 employers are expected to be on hand with room for more. The event is free for job seekers who are advised to come dressed for interviews and to bring multiple copies of their resume.

To expedite the process of connecting the right people to employers looking for specific skills, when registering, job seekers will be given a list of employers attending the event and the jobs they want to fill. Employer representatives will be accepting resumes and will have access to private interview space if they need it.

The event is being sponsored by Rep. Ron Paul (R-14th District), the City of Galveston, the Galveston Chamber of Commerce, the Galveston Economic Development Partnership, the University of Texas Medical Branch and Workforce Solutions.

JEFFERSON COUNTY DEVELOPMENT CORP. GETS RENEWED LIFE

More than 100 new jobs are in the sights of the long-inactive Jefferson County Industrial Development Corporation thanks to recent congressional legislation extending the benefits of a Katrina-related tax law to areas devastated by Hurricane Ike. Five Texas counties have now been authorized to issue tax-free bonds until Jan. 1, 2013 in amounts much larger than originally prescribed.

Prior to this fall's amendment, the act written in 2005 would only allow counties impacted by Hurricane Katrina to issue bonds up to \$10 million, an amount that economic development officials felt was too low. Due to limited capital, the Jefferson County Industrial Corporation had not convened since the mid-1990s. The new amendment adds five counties impacted by Hurricane Ike and raises the amount available.

The Jefferson County group is now looking at a \$330 million project to renovate a dormant refinery that would create 100-150 jobs in the mostly rural county. The two to three year renovation would employ about 300 construction workers.

The other four counties eligible to issue these higher limit tax-free bonds are Brazoria, Chambers, Galveston and Orange. For more information, go to http://www.irs.gov/taxexemptbond/index.html.

DEADLINE EXTENDED AGAIN TO ACCOMMODATE TEXANS

Four months and 23 days after Hurricane Ike made landfall, Texans are still registering with FEMA for assistance. In response to requests by the State of Texas, FEMA has extended the registration deadline.

The **current deadline is Feb. 20, 2009** for both FEMA applications for assistance and SBA loan applications. Simply filling out and submitting the SBA loan application may open the door for additional state and FEMA benefits to eligible individuals. Since the previous Jan. 12 deadline, more than 1,200 Texans have registered, about half from Harris County.

The deadline to apply for an SBA loan is Feb. 20. The deadline to apply for SBA Economic Injury Disaster Loans is June 15.
