<u>Project Description</u>: This building is 9 stories high and approximately 612,000 square feet. The building has 3 geared elevators. Each sustained damages during Hurricane Katrina. The scope of work is to install equipment that will enable the elevators to relocate to upper floors should the elevator pits become flooded again. With this equipment installation, the elevator cabs will relocate to upper floors with rising pit waters thus minimizing potential elevator cab water damage. This includes the installation of sump pumps within each elevator pit; installation of float switch devices for each elevator; installation of necessary relays within each elevator controller to enable new float switch devices/fire service to communicate with each other; installation of new PVC piping within each elevator pit to coincide with new sump pumps; and installation of wiring to coincide with above installations.
