- Per Clean Air Act National Emission Standards for Hazardous Air Pollutant regulations and Louisiana Administrative Code 33:III 5151, demolition activities related to Possible Asbestos-Containing Materials (PACM) must be inspected for ACM/PACM where it is safe to do so. The movement of wood or cellulose material, temporary housing or architectural components) may not leave the quarantined parish without written authorization from the commissioner of the Louisiana department of agriculture and forestry or his designee(s).
- If during the course of work, archaeological artifacts (prehistoric or historic) or human remains are discovered, the applicant shall stop work in the vicinity of the discovery and take all reasonable measures to avoid or minimize harm to the finds. The applicant shall inform their Public Assistance (PA) contacts at FEMA, who will in turn contact FEMA Historic Preservation (HP) staff. The applicant will not proceed with work until FEMA HP completes consultation with the SHPO. In addition, if unmarked graves are present, compliance with the Louisiana Unmarked Human Burial Sites Preservation Act (R.S. 8:671 et seq.) is required. The applicant shall notify the law enforcement agency of the jurisdiction where the remains are located within twenty-four hours of the discovery. The applicant shall also notify FEMA and the Louisiana Division of Archaeology at 225-342-8170 within seventytwo hours of the discovery. Failure to comply with these stipulations may jeopardize receipt of FEMA funding.
- Applicant is required to coordinate with local floodplain administrator regarding floodplain permit(s) prior to the start of any activities. In compliance with E0 11988, a completed 8-step process showing considered alternatives is attached. Per 44 CFR 9.11(d) (9), the replacement of building contents, materials and equipment, where possible, disaster proofing of the building and/or elimination of such future losses by relocation of those building contents, materials and equipment to or above the advisory base floodplain. Per 44 CFR 9.12, a cumulative final public notice was published 10/26/2007 and is attached. No further floodplain review will be forthcoming unless there should be a change in the scope of work.
