Every effort shall be made to minimize masonry damage through the use of the gentlest means of cleaning possible and through adequate protection of undamaged areas. Failure to comply with this stipulation may jeopardize receipt of FEMA funding
- 3. In keeping with the stipulations of the PA, all proposed repair activities should be done in-kind to match existing materials and form. Any change to the approved scope of work will require resubmission for re-evaluation under section 106 and consultation with the SHPO. Non-compliance may jeopardize the receipt of federal funding.
