

# Use Documentation Checklists to Help You Complete Your Proof of Loss Form

---

When filing a claim, documentation is one of the most important steps to completing your Proof of Loss form. To simplify and expedite the process, the Claims Office created checklists for the most common types of loss. The checklists are available to view or download from our website at [fema.gov/hermits-peak](https://fema.gov/hermits-peak). Copies will be available at our Mora, Las Vegas, and Santa Fe Claims Offices, Advocate Connects sessions and upcoming events.

Each type of loss or damage listed below may be eligible for compensation but must be a result of the Hermit's Peak/Calf Canyon Fire and flooding. Each list provides documentation options to submit with your Proof of Loss form. If you have questions about other losses or are having trouble finding what you need, speak with your Claims Navigator.

## Vehicle Losses Checklist

Vehicle damage may include vehicle repairs or replacement if your vehicle is a total loss. ## Evacuation Costs Checklist

Evacuation costs may include lodging, meals and incidentals, mileage and gas, specialized food items, or increased utility and/or fuel expenses. ## Flood Insurance Checklist



Residents who have a heightened risk of flooding and did not have or were not required to have flood insurance, may be eligible for compensation. View or download the Flood Insurance Checklist here:

## **Lost Income Checklist**

Lost income due to evacuation, work closure, or injury from the Hermit's Peak/Calf Canyon Fire may be eligible for compensation. Expenses due to debris removal or cleaning activities may be eligible for compensation. ## Home and Structure Repair Checklist

Damages to your home, including any structural or real property damage, may be eligible for compensation. Damage to your personal property including damage to the contents of your home may be eligible for compensation. ## Reforestation Checklist

Reforestation efforts to restore vegetation destroyed by the fire and flooding may be eligible for compensation. ## Agricultural Losses Checklist
