

FEMA Issues Public Notice: Alligator Drive

PANAMA CITY, Fla. — A public notice is now available that addresses the Federal Emergency Management Agency's (FEMA) intention to reimburse eligible applicants for costs to repair or replace facilities damaged by Hurricane Michael (FEMA-DR-4399-FL) occurring October 7, 2018 to October 19, 2018.

This notice concerns the Public Assistance (PA) project for Alligator Drive road repairs in Alligator Point, Franklin County, Florida, with hazard mitigation protection to prevent future storm erosion damage.
