FY 2009 SAFER CLOSEOUT MODULE

Grant closeout report forms are now available for completion in the e-Grants system for FY2009 Staffing for Adequate Fire and Emergency Response (SAFER) awardees (EMW-2009-XX-XXXXX) who have reached the end of the period of performance. For FY 2009 SAFER awardees that are still within their period of performance, you will have 90 days after the end of the period of performance to submit the closeout report.

Failure to submit the closeout report by the due date will affect the department’s ability to obtain reimbursements on all current grants as well as receive future funding under the Assistance to Firefighters Grant Program (AFG)

NOTE: The closeout forms for FY 2010 SAFER cannot be completed online at this time. Paper closeout forms are available for SAFER grantees FY 2005 through FY 2008 (EMW-2008-XX-XXXXX).
