## **Fiscal Year (FY) 2016 Intercity Passenger Rail (IPR) Program Frequently Asked Questions (FAQs)**

### **1. What is the purpose of the FY 2016 IPR Program?**

The purpose of the FY 2016 IPR Program is to provide funding to the National Passenger Railroad Corporation (Amtrak) to protect critical surface transportation infrastructure and the traveling public from acts of terrorism and to increase the resilience of the Amtrak rail system, as authorized by Section 1513 of the *Implementing Recommendations of the 9/11 Commission Act of 2007*, (Pub. L. No. 110-53) (6 U.S.C. § 1163).

The FY 2016 IPR Program plays an important role in the implementation of the National Preparedness System by supporting the building, sustainment, and delivery of core capabilities essential to achieving the National Preparedness Goal of a secure and resilient Nation. Building core capabilities requires the combined effort of the whole community, rather than the exclusive effort of any single organization or level of government. The FY 2016 IPR's allowable costs support efforts to build and sustain core capabilities across the Prevention, Protection, Mitigation, Response, and Recovery mission areas.

### **2. How much funding is available under the FY 2016 IPR Program?**

The total amount of funds distributed under the FY 2016 IPR Program will be \$10,000,000.

### **3. Who is eligible to apply for FY 2016 IPR funds?**

Amtrak is the only entity eligible to apply for funding under the IPR program.

### **4. What are the key milestones associated with the FY 2016 IPR?**

The key milestones associated with FY 2016 IPR Program are:

- February 16, 2016: Release date for FY 2016 IPR Notice of Funding Opportunity (NOFO)
- April 25, 2016: Applications for FY 2016 IPR are due to the Department of Homeland Security (DHS)/Federal Emergency Management Agency (FEMA)

### **5. How will the FY 2016 IPR funds be allocated?**

Amtrak is the only entity eligible to apply for funding under the IPR program. Therefore, Amtrak will receive the entire \$10,000,000 allocated by this program.

### **6. What are the changes in funding levels between FY 2015 and FY 2016?**

The FY 2016 funding level for the IPR grant program is the same as the FY 2015 level.

**7. What legislation authorized funding for the FY 2016 IPR Program?**

The IPR Program is authorized by Section 1513 of the *Implementing Recommendations of the 9/11 Commission Act of 2007*, (Pub. L. No. 110-53) (6 U.S.C. § 1163); and by the *Department of Homeland Security Appropriations Act, 2016* (Pub. L. No. 114-113).

**9. How will the FY 2016 IPR applications be submitted?**

Applying for an award under the IPR Program is a multi-step process:

Amtrak must submit its initial application through the Grants.gov portal at <http://www.grants.gov>. For Grants.gov support, Amtrak should contact the Grants.gov customer support hotline at (800) 518-4726.

Amtrak will be notified by FEMA and asked to proceed with submitting its complete application package in the [Non Disaster \(ND\) Grants System](#). Applicants in need of technical support with the ND Grants System should contact [ndgrants@fema.gov](mailto:ndgrants@fema.gov) or (800) 865-4076.

Completed applications must be submitted no later than 11:59 p.m. EDT, April 25, 2016.
