



## Resource Typing Definition for the National Qualification System Emergency Management

### LIASION OFFICER

<b>RESOURCE CATEGORY</b>	Emergency Management
<b>RESOURCE KIND</b>	Personnel
<b>OVERALL FUNCTION</b>	The Liaison Officer is the single point of contact for those that are not part of the command staff
<b>COMPOSITION AND ORDERING SPECIFICATIONS</b>	<ol style="list-style-type: none"> <li>1. This position can be ordered as a single resource</li> <li>2. Discuss logistics for this position, such as security, lodging, transportation, and meals, prior to deployment</li> <li>3. The position typically works 12 hours per shift, is self-sustainable for 72 hours, and is deployable up to 14 days</li> <li>4. Requestor may specify any additional qualifications necessary based on incident complexity and needs</li> </ol>

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

<b>DESCRIPTION</b>	<p>The Liaison Officer:</p> <ol style="list-style-type: none"> <li>1. Serves as the single point of contact for representatives of government departments and agencies (such as Federal, state, local, tribal, and territorial), as well as for jurisdictions, Nongovernmental Organizations (NGO), private sector organizations, and other cooperating agencies and organizations, and speaks on behalf of the Incident Commander (IC) or center director</li> <li>2. Ensures that those who are not part of the command staff, but who contribute to the incident's prevention, protection, mitigation, response, and recovery, receive appropriate information and exchange communications with the Incident Management Team (IMT) or Emergency Operations Center staff.</li> </ol>	Not Specified
