LAHAINA, Maui - Mwurin kisiniei laud me wiawi nan Maui ni August 8, 2023, dodoahk apwal me peneinei tohto, aramas me mie arail business, o government diar iei kamwakel in kihd.

FEMA kihieng U.S. Army Corp of Engineers (USACE) en pwukoahki sawase kamwakelehda wasahn kouson.

Ni August, 2024, kihd o wasa isihsdahkan kamwakel dahsang ehr ni ihmw 1,390. Mwurin soil sampling me erosion control measure ah kaneknekda, ihmw koaros kopwurupwur lahng County en Maui ni September, 2024. Kemwekid en dodoahk wet mweidengehr tohn community en apply oang permit en wie ihmw o tep wie ihmw. Nan sounpwung weneu kaudahn ihmw ah wiwiawi, mie peneinei iou mwokid long nan imwerail kapw nan Lahaina mwohn Thanksgiving.

Dodoahk wet uhd kosoulahng kemwekid en commercial debris. Likin commercial property waluh, wasa teikan nan Lahaina kamwakeldahr oh mwahu. E dehde me koaros commertial property pan kaneknekda ni toapin pahr en 2025.

Pwe kamwakel en kihd de debris, ah kereniengehr keimwsekla, aramas me kin kouson nan Lahaina tepdahier kilang weklahn arail wasahn kouson, o malaulau lahr sdohsahkan me kin kamwakid kihd la ni Temporary Debris Storage i Olowalu, West Maui. Ansou iou me FEMA pan diarada wasahn kihd me mwahu, repa kamwakid sang kihd koaros sang wasa me re dodoahgki.

Dodoahk en kemwekid kihd wiawihdahsang ni en mehn Hawaii poalioan taihk'.

Tohn dodoahk en FEMA o USACE alehdi training sang pelien tiahk en Hawaii. Pwe en kak mie wahu oh silepen tiahk in Hawaii ' training wiawi on-site. Native Hawaiian oh soun kawehd en pelien tiahk alahlda pwe ren katanga dodoahk wet.

Kenekid kesempwal wiawieng diwpsou en mahs. Pwihn iou pilipilda nan USACE pwe ren tehk mwahu iei kepikipik en sahpu. Ehu wasa me re tehk oh pan kamwahuhla iei, Mwolen Kopwung en Hawaii. USACE kiheng pali laud en dodoahk (95%) ieng local construction company pwe en kak sawase local economy.

Nan dodoahk wet, USACE diarada 29 historic and cultural significant propeties me pan anahne. lek 6 mekar properties omw iten selekted i en technique me enong shoring me bracing, mekar a pahnken kinwel an pahkilik a shells a ngeniwren pahnka restoration. Kouson pahiou sang nan kouson weneu me pilipil da kamwakeldahr.

Dodoahk wet ah wiewiawi, FEMA o USACE peihk eng arail pwukoah nan wasa wet o kaskasik ehr soahng mwahu teikan oang Maui.
