## Last Week to Visit FEMA Specialists at Home Improvement Stores

Oklahomans affected by the severe storms and flooding that occurred from May 7 to June 9, 2019 have until Aug. 14 to register for disaster assistance from FEMA. Survivors can register online at <a href="www.DisasterAssistance.gov">www.DisasterAssistance.gov</a> or toll-free at 800-621-3362 (voice, 711/VRS - Video Relay Service). Multilingual operators are available. (Press 2 for Spanish). For TTY call 800-462-7585. Lines are open 7 a.m. to 11 p.m. daily.

Registering with FEMA is the first step toward qualifying for disaster assistance, which may include grants to help homeowners and renters pay for temporary housing, essential home repairs, personal property replacements and disaster-related needs not covered by insurance.
