

# Preliminary Flood Maps for Portions of Collin County, Texas, are Ready for Public View

**DENTON, Texas** – Preliminary Flood Insurance Rate Maps (FIRMs) are available for review by residents and business owners in portions of Carrollton, Dallas, Plano, Richardson; and unincorporated areas of Collin County, Texas. Property owners are encouraged to review the latest information to learn about local flood risks and potential future flood insurance requirements. Community stakeholders can identify any concerns or questions about the information provided and participate in the appeal and comment periods for the maps.

For this physical map revision, the Flood Insurance Rate Maps for Collin County, Texas, serve multiple purposes, including defining Special Flood Hazard Areas (SFHAs) and setting rates for flood insurance. SFHAs are areas at high risk for flooding. Communities and residents can use the information to make informed decisions about building, development, and flood insurance.

FEMA stresses that flooding can and does happen outside of the most vulnerable areas.

“Flooding is not restricted to coastal communities; where it can rain, it can flood,” said FEMA Region 6 Administrator Tony Robinson. “More than 25 percent of flood damage occurs outside the Special Flood Hazard Area, yet most homeowner’s insurance policies do not cover the effects of flooding. Obtaining flood insurance is one of the smartest ways for individuals or businesses to protect themselves.”

To review the preliminary flood maps, visit your local floodplain administrator (FPA). A FEMA map specialist can help identify your community FPA.
