West Virginia – Severe Storms, Straight-line Winds, Flooding, Landslides, and Mudslides

On July 27, 2015, Governor Earl Ray Tomblin requested a major disaster declaration due to severe storms, straight-line winds, flooding, landslides, and mudslides during the period of July 10-14, 2015. The Governor requested a declaration for Individual Assistance for three counties, Public Assistance for eight counties, and Hazard Mitigation statewide. During the period of July 17-21, 2015, joint federal, state, and local government Preliminary Damage Assessments (PDAs) were conducted in the requested counties and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the state and the affected local governments, and that Federal assistance is necessary.1

On August 7, 2015, President Obama declared that a major disaster exists in the State of West Virginia. This declaration made Public Assistance requested by the Governor available to state and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by the severe storms, straight-line winds, flooding, landslides, and mudslides in Braxton, Clay, Lincoln, Logan, Nicholas, Roane, Webster, and Wood Counties. This declaration also made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures statewide.²

¹ The Preliminary Damage Assessment (PDA) process is a mechanism used to determine the impact and magnitude of damage and resulting needs of individuals, businesses, public sector, and community as a whole. Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

² When a Governor's request for major disaster assistance under the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).
