# District of Columbia – Severe Storms FEMA-4073-DR

### Declared July 31, 2012

On July 1, 2012, Mayor Vincent M. Gray requested an emergency declaration due to a severe storm. Mayor Gray amended his initial request on July 20, 2012, and requested a major disaster declaration due to severe storms during the period of June 29 to July 1, 2012. The Mayor requested a declaration for Public Assistance and Hazard Mitigation for the District of Columbia. During the period of July 12-17, 2012, joint federal and District of Columbia Preliminary Damage Assessments (PDAs) were conducted in the District of Columbia and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the state and the affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On July 31, 2012, President Obama declared that a major disaster exists in the District of Columbia. This declaration made Public Assistance requested by the Mayor available to the District of Columbia and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by the severe storms in District of Columbia. This declaration also made Hazard Mitigation Grant Program assistance requested by the Mayor available for hazard mitigation measures in the District of Columbia.<sup>2</sup>

Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).

Destroyed – total loss of structure, structure is not economically feasible to repair, or complete failure to major structural components (e.g., collapse of basement walls/foundation, walls or roof);

o Major Damage – substantial failure to structural elements of residence (e.g., walls, floors, foundation), or damage that will take more than 30 days to repair;

Minor Damage – home is damaged and uninhabitable, but may be made habitable in short period of time with repairs; and

o Affected – some damage to the structure and contents, but still habitable.
