### Preliminary Damage Assessment Report

# Agua Caliente Band of Cahuilla Indians – Tropical Storm Hilary FEMA-4746-DR

### Declared October 18, 2023

On September 14, 2023, Chairman Reid D. Milanovich requested a major disaster declaration due to Tropical Storm Hilary during the period of August 19-21, 2023. Chairperson Milanovich requested a declaration for Public Assistance and Hazard Mitigation for the Agua Caliente Band of Cahuilla Indians. On August 29, 2023, joint federal, tribal, and local government Preliminary Damage Assessments (PDAs) were conducted in the requested areas and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the tribal nation and the affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On October 18, 2023, President Biden declared that a major disaster exists for the Agua Caliente Band of Cahuilla Indians. This declaration made Public Assistance available to the Agua Caliente Band of Cahuilla Indians. This declaration also made Hazard Mitigation Grant Program assistance available for hazard mitigation measures for the Agua Caliente Band of Cahuilla Indians.<sup>2</sup>
