### Preliminary Damage Assessment Report

## **Tennessee – Severe Storms, Tornadoes, and Flooding FEMA-4792-DR**

### Declared June 17, 2024

On June 7, 2024, Governor Bill Lee requested a major disaster declaration due to severe storms, tornadoes, and flooding during the period of May 8-9, 2024. The Governor requested a declaration for Individual Assistance for six counties, Public Assistance for 12 counties, and Hazard Mitigation statewide. During the period of May 17-30, 2024, joint federal, state, and local government Preliminary Damage Assessments (PDAs) were conducted in the requested areas and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the state and the affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On June 17, 2024, President Biden declared that a major disaster exists in the State of Tennessee. This declaration made Public Assistance requested by the Governor available to state and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by the severe storms, tornadoes, and flooding in Cannon, Cheatham, Giles, Hamilton, Jackson, Macon, Maury, Montgomery, Polk, Smith, Sumner, and Warren Counties. This declaration also made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures statewide.<sup>2</sup>

<sup>1</sup> The Preliminary Damage Assessment (PDA) process is a mechanism used to determine the impact and magnitude of damage and resulting needs of individuals, businesses, public sector, and community as a whole. Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

- Destroyed total loss of structure, structure is not economically feasible to repair, or complete failure to major structural components (e.g., collapse of basement walls/foundation, walls or roof);
- Major Damage substantial failure to structural elements of residence (e.g., walls, floors, foundation), or damage that will take more than 30 days to repair;
- Minor Damage home is damaged and uninhabitable, but may be made habitable in short period of time with repairs; and
- o Affected some damage to the structure and contents, but still habitable.
