

**FEMA PUBLIC NOTICE OF AVAILABILITY  
DRAFT ENVIRONMENTAL ASSESSMENT  
FOR TRANSPORTABLE TEMPORARY HOUSING UNIT GROUP SITE  
KNOWN AS THE HERITAGE HEIGHTS GROUP HOUSING SITE  
FORT MYERS, FLORIDA**

The Federal Emergency Management Agency (FEMA) hereby gives notice to the public of its intent to construct the Heritage Heights Group Housing Site. FEMA has prepared a draft Environmental Assessment (EA) for a proposed Manufactured Housing Unit (MHU) group site. The site may provide suitable temporary housing opportunities for individuals and families displaced under the major disaster declaration for Hurricane Ian (FEMA-4673-DR-FL) for the incident period beginning September 23, 2022, and ending November 4, 2022, signed by the President on September 29, 2022.

The proposed action includes developing an approximately 9.3-acre site for up to approximately 59 MHUs to be located at 10660 Golden Journey Rd, Fort Myers, Lee County, Florida (GPS Coordinates: 26.510561, -81.927553). Activities may include, where necessary, site clearing, grading, road construction, the placement of utilities (electricity, telephones, water, and sewer), and the transport and installation of manufactured homes to the site. The group site is intended to be operational for up to 18 months.

In accordance with the National Environmental Policy Act of 1969 (NEPA), the Council on Environmental Quality (CEQ) regulations implementing NEPA (40 Code of Federal Regulations (CFR) Parts 1500–1508), FEMA’s Instruction 108-1-1 for implementing NEPA, the National Historic Preservation Act, Executive Order 11988, Executive Order 11990, and 44 CFR Part 9, FEMA has prepared a draft Environmental Assessment (EA). An alternatives analysis was performed, which included the evaluation of the potential impacts of the proposed action on the human and natural environment, and the no action alternative. The draft EA summarizes the purpose and need, site selection process, affected environment, and potential environmental consequences associated with the proposed action and no action alternatives.

If no substantive comments are received, the draft EA will become final and no further public noticing will be conducted.

Presidential Executive Orders 11988 and 11990 require all federal actions in or affecting the floodplain or wetlands be reviewed for opportunities to relocate and evaluated for social, economic, historical, environmental, legal, and safety considerations. The proposed group site is located within a Special Flood Hazard Area (SFHA), per Lee County Flood Insurance Rate Map (FIRM) #12071C0418G, dated 11/17/2022. Location of this site within the SFHA is required due to limited

site viability within proximity to the population of disaster survivors requiring direct housing assistance. Alternative sites, as well as the no action alternative, were analyzed and dismissed due to a variety of factors including property size limitations, access to utilities, and willingness of landowners to sign a lease agreement with FEMA.

Due to the emergency nature of this action, the public comment period will be brief and limited to a seven-day (7-day) comment period which will end on 03/23/2023.
