Notice of Availability of the Programmatic Environmental Assessment for the Post-Hurricanes Irma and Maria and Increased Seismic Activity for Puerto Rico's Public Facilities Infrastructure Recovery and Resiliency FEMA-DR-4336-PR, FEMA-DR-4339-PR & FEMA-DR-4473-PR

Notification is hereby given to the public of the intent of the Department of Homeland Security-Federal Emergency Management Agency (DHS-FEMA) to provide federal funding to Puerto Rico, Applicant, for the repair of damaged public facilities caused by hurricanes Irma and Maria, and the increased seismic activity occurring in 2019 and 2020. A disaster declaration was issued for Hurricane Maria on September 20, 2017, encompassing the entirety of Puerto Rico. Since the signing of the disaster declaration in response to the hurricanes, Puerto Rico has experienced increased seismic activity leading to an additional disaster declaration signed on January 16, 2020 and applied to designated Municipalities within Puerto Rico. The declaration authorized federal public assistance to affected communities and certain non-profit organizations per FEMA, and in accordance with the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1974 (42 U.S.C. 5121-5207), as amended; the Sandy Recovery Improvement Act (SRIA) of 2013; and the Bipartisan Budget Act of 2018 (Public Law 115-123). The Central Office of Recovery, Reconstruction and Resiliency (COR3) is the Applicant for FEMA grants and multiple agencies may be subrecipients for specific projects.

The need for this action is to repair public facilities to current codes and standards, equitably restore or increase resiliency measures, reopen facilities closed because of disaster events, support alignment to subrecipient needs of restoring facility services, align facilities with local laws, and provide hazard mitigation to increase resiliency in response to future disaster events. The elements of public facilities covered under this Programmatic Environmental Assessment (PEA) are defined as emergency response facilities; publicly owned and non-profit hospitals, medical centers, and health care facilities; Non-profit houses of worship and churches; publicly owned and non-profit higher education facilities; State and municipal government offices; Public housing communities; Judiciary buildings and correction facilities; Public recreation facilities, Libraries, archives, and museums; and Puerto Rico Industrial Development Company facilities. The goal is to ensure resilient and upgraded public facilities will allow services to remain open during future disaster events, which will enable quicker emergency response times, increase public safety, reduce injury and death, and increase survivability.

In accordance with the National Environmental Policy Act (NEPA), this PEA has been prepared to assess the potential impacts of the proposed action on the physical, biological, cultural, and human environments. DHS-FEMA's requirement of addressing floodplain management and wetlands protection in accordance with 44 CFR Part 9 is incorporated within the PEA. This Public Facilities PEA is available for agency and public review and comment for a period of thirty (30) days. The public information process will include a public notice in both English and Spanish with information about the proposed action in the *Primera Hora* and *El Nuevo Día* newspapers. The publicly available materials will include both English and Spanish translated versions of the PEA, Executive Summary, and Public Notice.
