FEMA PUBLIC NOTICE OF AVAILABILITY DRAFT ENVIRONMENTAL ASSESSMENT TUCKAHOE MANSION BREAKWATER CONSTRUCTION PROJECT MARTIN COUNTY, FLORIDA

The Federal Emergency Management Agency (FEMA) hereby gives notice to the public of its intent to reimburse eligible applicants for eligible costs to repair or replace facilities damaged by **Hurricane Irma** occurring during the incident period of **September 4, 2017, to October 18, 2017**. This notice applies to the Public Assistance (PA) project for the Martin County proposed offshore breakwater construction project in Indian River Lagoon located in Jensen Beach, Martin County, Florida, implemented under the authority of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. §§ 5121-5207.

Under a major disaster declaration, **FEMA-DR-4337-FL**, signed by President Trump on **September 10, 2017**, Martin County was designated as adversely affected by the disaster and eligible for PA funding.

This public notice concerns activities pertaining to the Martin County proposed offshore breakwater system construction project adjacent to the historic Tuckahoe Mansion. The proposed construction activities would occur along Indian River Lagoon, 60 to 230 feet offshore from Indian Riverside Park, located at 1707 NE Indian River Drive, Jensen Beach, Florida 34957. The approximate start and end GPS coordinates for the entire length of the breakwater system are 27.224145, -80.211277 to 27.229917, -80.214137.

The proposed project is to construct an offshore breakwater system composed of 24 segments totaling approximately 2,365 linear feet (LF) of shoreline, 2,165 LF of stone toe protection, oyster reefs, and seagrass recruitment area. The project would also include mangrove planting, and removal of invasive or toxic plant species.

In accordance with the National Environmental Policy Act of 1969 (NEPA), the Council on Environmental Quality (CEQ) regulations implementing NEPA (40 Code of Federal Regulations (CFR) Parts 1500 to 1508), FEMA's Instruction 108-1-1 for implementing NEPA, the National Historic Preservation Act, Executive Order 11988, Executive Order 11990, and 44 CFR Part 9, FEMA has prepared an Environmental Assessment (EA). An alternatives analysis was performed, which included the evaluation of the proposed action, and the No Action alternative. The Endangered Species Act (ESA) requires federal agencies to consult with the United States Fish and Wildlife Service (USFWS) and National Marine Fisheries Service (NMFS) for affects to federally listed threatened and endangered species. Existing Programmatic Biological Opinions with NMFS and USFWS standard species conditions would be utilized to minimize impacts to listed species by applying appropriate terms and conditions.

The National Historic Preservation Act (NHPA) requires federal agencies to take into account the effect of their undertakings on historic properties. FEMA consulted with the State Historic Preservation Officer (SHPO) and received concurrence for a determination of *No Adverse Effect to Historic Properties*. Tribal consultation letters were submitted to six federally recognized tribes with vested interest in Martin County, Florida. None of the tribes express any objections to the proposed project.

Presidential Executive Orders 11988 and 11990 require that all federal actions in or affecting the floodplain or wetlands be reviewed for opportunities to relocate and evaluated for social, economic, historical, environmental, legal, and safety considerations. The proposed breakwater system would be located within a special flood hazard area, per Martin County Flood Insurance Rate Map (FIRM) #12085C0152 H, dated February 19, 2020. The breakwater system is a functionally dependent facility that provides a higher level of flood protection to adjacent areas and would also support habitat for wildlife. If no action is taken the shoreline would continue to be vulnerable to higher wave action and erosion.

This notice serves as the final public notice regarding the above-described action proposed for funded by the FEMA PA program.
