Aninisin Imweimw:

Aninisin Imweimw epwene awora moni ika wenecharen aninis, mi pachenong:

Aninisin Nenien Rent: Monien aninis ngeni rentin mwochomwochen imweimw nupwen ra fori forun kena ra popseni katano ra kan ofor ngeni eomuwe aewin nenien nonom, ika nupwen asiwinino ngeni imweimwfocheno.

Momosefanin Mon Imweimw: Monien Aninisin momosefanin ren mwochomwochen imweimw kena.

Forun Imw: Monien aninisin ren an chon imweimw repwe fori imwer ese insure a tano seni ewe katano. Ewe aninis a kan ren forun ewe imw ren an epwe tumun, nimeoch me pwan oforino non fichin nonomun non.

Asiweinim Imw: Monien aninis ren chom imweimw kena ina ir repwe kan asiwini ika awuusefani ar aewin nenien nonom a kan ew punguno seni ewe katano.
