

## Resource Typing Definition for Response Operational Coordination

## AIR SUPPORT GROUP SUPERVISOR

RESOURCE CATEGORY	Incident Management
RESOURCE KIND	Personnel
OVERALL FUNCTION	The Air Support Group Supervisor oversees staff who establish and operate bases for helicopters, maintain liaison with incident fixed wing bases and are responsible for timekeeping for all aviation resources assigned to the incident.
COMPOSITION AND ORDERING SPECIFICATIONS	<ol> <li>This position can be ordered as a single resource.</li> <li>Discuss logistics for deploying this position, such as working conditions, length of deployment, security, lodging, transportation and meals, prior to deployment.</li> <li>Requestor specifies any additional qualifications necessary, based on incident complexity and needs.</li> </ol>

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

DESCRIPTION	<ol> <li>The Air Support Group Supervisor:         <ol> <li>Establishes or transitions into a group under the Operations Section in the Incident Command System (ICS)</li> <li>Supervises and configures the group with units as necessary</li> <li>Coordinates the ground needs of flight crews and their aircraft in conjunction with the Air Operations Branch Director</li> <li>Assists and coordinates with the Air Tactical Group Supervisor to help ensure mission success and crew safety</li> <li>Assists the Air Tactical Group Supervisor and Air Operations Branch Director during in-flight emergencies (IFE)</li> <li>Ensures the availability of and access to adequate aircraft servicing and fuel</li> <li>Accounts for aircrew between missions and provides for crew rest, feeding and billeting needs</li> <li>Coordinates with local airfield managers and fixed base operators (FBO)</li> <li>Reports mission-essential information to the Air Operations Branch Director</li> <li>Coordinates with the Air Tactical Group Supervisor to provide information to the Air Operations Branch Director for the daily situation report</li> </ol> </li> </ol>	Not Specified

EXPERIENCE	<ol> <li>Successful completion of the National Qualification System (NQS) Position Task Book (PTB) for the NIMS Air Support Group Supervisor, or equivalent AHJ documentation</li> <li>Experience in an air operations position</li> </ol>	Military rating (current or former) as a pilot or navigator may fulfill air operations experience requirement.
PHYSICAL / MEDICAL FITNESS	Light	The NIMS Guideline for the NQS defines Physical/Medical Fitness levels for NQS positions.
CURRENCY	Functions in this position or a higher position during a qualifying incident, planned event, exercise, drill or simulation at least once every three years	<ol> <li>Military experience may fulfill this currency requirement.</li> <li>A higher position is one for which this position is a prerequisite within the Operations Section.</li> </ol>
