



## Resource Typing Definition for Response Operational Coordination

### DOCUMENTATION UNIT LEADER

<b>RESOURCE CATEGORY</b>	Incident Management
<b>RESOURCE KIND</b>	Personnel
<b>OVERALL FUNCTION</b>	The Documentation Unit Leader oversees unit staff who maintain incident files and data for legal, analytical and historical purposes, including a complete record of the major steps taken to resolve the incident.
<b>COMPOSITION AND ORDERING SPECIFICATIONS</b>	<ol style="list-style-type: none"> <li>1. This position can be ordered as a single resource,</li> <li>2. Discuss logistics for deploying this position, such as working conditions, length of deployment, security, lodging, transportation and meals, prior to deployment.</li> <li>3. Requestor specifies any additional qualifications necessary, based on incident complexity and needs.</li> </ol>

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

<b>DESCRIPTION</b>	The Documentation Unit Leader: <ol style="list-style-type: none"> <li>1. Establishes or transitions into a unit under the Planning Section</li> <li>2. Configures unit with personnel to support the incident</li> <li>3. Oversees the maintenance of accurate, complete, up-to-date incident files</li> <li>4. Ensures that each section maintains and submits appropriate files for post-incident documentation purposes</li> <li>5. Provides duplication services to support incident operations</li> <li>6. Assists with compiling, reproducing and distributing the Incident Action Plan (IAP)</li> <li>7. Ensures that all personnel who handle data or intelligence are aware of and maintain a document security plan to manage the confidentiality and security of any classified, confidential, sensitive and For Official Use Only (FOUO) documentation, intelligence, data or incident information</li> </ol>	Not Specified

<b>TRAINING</b>	Completion of the following: <ol style="list-style-type: none"> <li>IS-100: Introduction to the Incident Command System, ICS-100</li> <li>IS-200: Basic Incident Command System for Initial Response, ICS-200</li> <li>ICS-300: Intermediate Incident Command System for Expanding Incidents</li> <li>IS-700: National Incident Management System, An Introduction</li> <li>IS-800: National Response Framework, An Introduction</li> <li>E/G/L 0191: Emergency Operations Center/Incident Command System Interface</li> </ol>	The National Incident Management System (NIMS) Training Program defines a national baseline to guide and promote NIMS training. It provides recommendations to assist Authorities Having Jurisdiction (AHJ) in developing their own training plans, tailored to their specific needs.
<b>EXPERIENCE</b>	<ol style="list-style-type: none"> <li>Successful completion of the National Qualification System (NQS) Position Task Book (PTB) for the NIMS Documentation Unit Leader, or equivalent AHJ documentation</li> <li>Experience in gathering, updating and applying situational information to make informed strategic decisions and in exchanging relevant incident information</li> </ol>	Not Specified
<b>PHYSICAL / MEDICAL FITNESS</b>	Light	The NIMS Guideline for the NQS defines Physical/Medical Fitness levels for NQS positions.
<b>CURRENCY</b>	Functions in this position or a higher position during a qualifying incident, planned event, exercise, drill or simulation at least once every five years	A higher position is one for which this position is a prerequisite.
<b>PROFESSIONAL AND TECHNICAL LICENSES AND CERTIFICATIONS</b>	Not Specified	Not Specified
