**PUBLIC ASSISTANCE SITE INSPECTOR**

<b>RESOURCE CATEGORY</b>	Public Assistance
<b>RESOURCE KIND</b>	Personnel
<b>OVERALL FUNCTION</b>	The Public Assistance (PA) Site Inspector assesses and documents damage in collaboration with PA grant recipients, applicants, pass-through entities, or subrecipients—stakeholders collectively called “applicants”.
<b>COMPOSITION AND ORDERING SPECIFICATIONS</b>	<ol style="list-style-type: none"> <li>1. This position can be ordered as a single resource</li> <li>2. Discuss logistics for deploying this position, such as working conditions, length of deployment, security, lodging, transportation, and meals, prior to deployment</li> <li>3. Requestor specifies any necessary specialty areas, such as roads or dams, based on incident needs</li> </ol>

Each type of resource builds on the qualifications of the type below it. For example, Type 1 qualifications include the qualifications in Type 2, plus an increase in capability. Type 1 is the highest qualification level.

<b>DESCRIPTION</b>	<p>The PA Site Inspector:</p> <ol style="list-style-type: none"> <li>1. Conducts inspections at damage sites</li> <li>2. Documents grant applicants' damage claims</li> <li>3. Compiles documentation and enters data into grant management software</li> <li>4. Creates a detailed Damage Description and Dimensions form</li> <li>5. Creates maps, photo markups, and sketches to supplement written reports that the grant management software stores and generates</li> <li>6. Provides good customer service to applicants through prompt follow-up and a professional demeanor</li> </ol>	Not Specified
