Re: Tribal Consultation in Alaska

Dear Tribal Leader:

The U.S. Department of Homeland Security's Federal Emergency Management Agency (FEMA) remains committed to its responsibility to engage in consultation and collaboration with tribal officials, consistent with [Executive Order 13175](#), *Consultation and Coordination with Indian Tribal Governments*, reaffirmed by President Biden's "[Memorandum on Tribal Consultation and Strengthening Nation-to-Nation Relationships](#)."

In 2013, the Sandy Recovery Improvement Act of 2013 (SRIA) amended the [Robert T. Stafford Disaster Relief and Emergency Assistance Act \(Stafford Act\)](#) to provide federally recognized Indian tribal governments (Tribal Nations) the pathway to request a Presidential emergency or major disaster declaration. After consulting with Tribal Nations, FEMA released the [Tribal Declarations Pilot Guidance in 2017](#), which serves as a resource for Tribal Nations on Stafford Act declarations, disaster assistance, and related requirements. The Guidance also includes the criteria that FEMA uses to evaluate declaration requests from Tribal Nations and make recommendations to the President regarding whether to declare an emergency or major disaster.

The [2022-2026 FEMA Strategic Plan Goal 1.2](#) includes a commitment to transform our service to Tribal Nations to acknowledge tribal sovereignty and respond to the needs of each Tribal Nation. The [2022-2026 FEMA National Tribal Strategy Goal 1.4](#) further commits FEMA to increase Tribal Nation's access to FEMA programs and resources by affecting policy changes.

Consistent with our responsibilities and commitments, FEMA invites Tribal Nations to attend a series of government-to-government listening sessions and tribal consultations on the Tribal Declarations Pilot Guidance.
